## **WAIVER OF LIABILITY, ASSUMPTION OF RISKS, AND PHOTO RELEASE**

KNOWING AND UNDERSTANDING THE RISKS, I AGREE TO VOLUNTARILY AND KNOWINGLY ASSUME ALL THOSE RISKS IN ADVANCE.

In the event I become distressed or call for first aid, I hereby represent that I would like assistance and will not hold any of the Released Parties or any other competitors responsible for their actions in attempting the performance of rescue or first aid.

I agree that this waiver and assumption of risks is intended to be as broad as is permitted by law and that if any portion of it is held invalid, it is agreed that the other portions shall continue in full force and effect.

I HAVE READ THIS AGREEMENT AND THE RULES OF THE CONTEST, FULLY UNDERSTAND THEIR TERMS, AND UNDERSTAND THAT I AM GIVING UP SUBSTANTIAL RIGHTS, INCLUDING MY RIGHT TO SUE.
